

DECLARATION, RELEASE AND EXEMPTION FROM LIABILITY AND ASSUMPTION OF RISKS AND INDEMNIFICATION

Boulangerie St-Méthode “Ok Campagnolo” Contest

I hereby declare that:

1. When I participated in the “**Ok Campagnolo**” Contest (the “Contest”), I was of legal age of majority in my province or territory of residence, and the personal information that I provided in connection with this contest was accurate. Without limiting the generality of the foregoing, I further declare as follows:
2. I am not: an employee, representative or mandatary of the Organizer, of any company, corporation, trust or other legal entity controlled by or related to it, or of its advertising and promotion agencies, suppliers of prizes, materials and services related to the present Contest, or a member of their immediate family (brother, sister, child, father, or mother) or their legal or common-law spouse, and I am not residing in the same household as any such employees, representatives or mandataries.
3. I have answered the mathematical skill-testing question within the time limit specified, without any mechanical or other assistance of any kind whatsoever, and I have complied with all other rules of the Contest. I agree to accept any decisions related to this Contest as final and binding.
4. I understand that the prize that I am eligible to win (the “prize”) consists of the following: one (1) of the two hundred and fifty (250) Google Home devices with a total value of \$50,000.
5. The prizes are neither transferable nor assignable and must be accepted as is, with no cash or other substitution, except at the sole discretion of the Organizer. I will not be entitled to the cash amount of any difference between the stated value and the actual value of the prize. The Organizer reserves the right, at its sole and absolute discretion, to replace a prize with another prize of equivalent value, if for any reason whatsoever the prize cannot be awarded as described.
6. I confirm that by participating in this Contest, I have consented and consent to the collection, use and disclosure of my personal information by the sponsor and its authorized agents for the purpose of administering this Contest and awarding the prizes. By accepting the present document and accepting the prize, I consent to the use of my first and last names, address (city, province), voice, statements, image, photographs and any other representations and records concerning me, for purposes of publicity, without any other notice or any remuneration, in any form of publication or presentation, such as newspapers and other publications, as well as in radio and television broadcasts, in films and interactive media, and on the Internet, worldwide.

EXEMPTION FROM LIABILITY CLAUSE – PLEASE READ CAREFULLY

- (i) I agree that the awarding of the prize fulfils my rights as a participant in and winner of the Contest, and I hereby agree that I will not take legal action against and that I completely and forever release Boulangerie St-Méthode Inc., its respective advertising and promotion agencies, the event manager, the promotional partners, the Contest supervision organization, the members of their respective groups (including their divisions, parent corporations, subsidiaries, and any other corporations that are respectively affiliated with them, directly or indirectly) and all of their respective agents, associates, employees, representatives, shareholders, proprietors, directors, administrators, successors and assigns (collectively, the “beneficiaries of the exemption”) from all claims, demands, actions, causes of action, damages or other losses of any kind whatsoever, known or unknown, in law or in court, that I or my heirs, executors, successors or assigns may have now or in future with regard to any of the beneficiaries of the exemption regarding the Contest or the prize.

- (ii) I also agree not to take legal action against the beneficiaries of the exemption from any liability toward me and toward my heirs, executors, receivers, successors or assigns for any loss or damage and any claim or demand arising from bodily harm (including death) or material harm suffered by the undersigned, whether directly or indirectly related to the event or the prize and whether or not caused by the fault of the beneficiaries of the exemption; and I hereby release them from any such liability fully and permanently.
- (iii) Without limiting the general application of the foregoing, I agree not to take legal action against any of the beneficiaries of the exemption, and I acknowledge that the beneficiaries of the exemption shall not be liable for any injury, accident, death or other loss, damage or harm related directly or indirectly to the event or arising in the context of my enjoying the prize, whether or not caused by the beneficiaries of the exemption, including any medical care or treatment that the beneficiaries of the exemption or any other person authorized by one of them may provide to me in case of injury or illness when I benefit from the prize or attend the event.
- (iv) I also acknowledge that none of the beneficiaries of the exemption has given any guarantee regarding the prize and that I will address any claim regarding the prize exclusively to the supplier, manufacturer or giver of the prize, as the case may be.
- (v) I assume all risks and full responsibility for any losses, injuries, deaths, damage or other harm as well as for any obligations related to such losses, injuries, damage or harm arising directly or indirectly from the event or the prize or occurring in the context of my participation in the event or my enjoyment of the prize, whether or not these losses, injuries, deaths, damages or other harm have been caused by the fault of the beneficiaries of the exemption.
- (vi) I hereby agree to indemnify the beneficiaries of the exemption and hold them harmless from any loss, liability, damages or costs that they may incur as a result of requests, claims or causes of action filed by myself, the undersigned, or on my behalf, or my heirs, executors, receivers, successors or assigns, whether or not the claim is based on the fault of the beneficiaries of the exemption.
- (vii) I hereby agree that this "release and exemption from liability and assumption of risks" extends to all acts of omission or commission by the beneficiaries of the exemption and shall be interpreted as broadly and inclusively as possible under the laws of Canada, regardless of where the event occurs, and that if any part of this document is declared null, it is understood that the rest of this document will nevertheless continue in full force.

I acknowledge that once I have read the present declaration and release from liability, I must accept it in order to enter the Contest.

I DECLARE THAT I HAVE CAREFULLY READ THIS DECLARATION, RELEASE AND EXEMPTION FROM LIABILITY AND ASSUMPTION OF RISKS, HAVE FULLY UNDERSTOOD ITS CONTENT, AND HAVE UNDERSTOOD THAT I HAVE GIVEN UP IMPORTANT RIGHTS BY AGREEING TO THE PRESENT DOCUMENT, AND THAT I HAVE ACCEPTED IT OF MY OWN FREE WILL, AND THAT NO ASSURANCES OR REPRESENTATIONS HAVE BEEN MADE TO ME. I DECLARE THAT MY AGREEMENT TO THIS DOCUMENT CONSTITUTES A TOTAL AND UNCONDITIONAL EXEMPTION FROM ANY LIABILITY SUBJECT TO ALL OF THE LIMITATIONS PERMITTED BY LAW. THE PRESENT DOCUMENT IS BINDING UPON MY LAWFUL HEIRS AND SUCCESSORS.
